## 2008-2009 Tuition Contract – Grades 6-10

- The School reserves a place only when the registration form with the \$200 registration fee, this tuition contract and the Tuition Management System's enrollment form with any applicable fee (see below) are accepted by the School. **Only one TMS form/fee is required per family.**
- The student's right to attend class is dependent on making **all** payments as scheduled.
- The School reserves the right to require the withdrawal of any student who, in the judgment of the School, is not making satisfactory progress or is detrimental to the School and its philosophy.
- Report cards and student records will not be released until all payments and other financial commitments are met. Students with unpaid accounts will not be allowed to re-enroll.

### Payment Options through Tuition Management Systems\*

1. Annual payment due June 1, 2008: **no enrollment fee**
2. 3 Pay Plan—34% of tuition due June 1, 2008, 34% due September 1, 2008 and 32% due December 1, 2008. **\$10 enrollment fee**
3. 10 monthly payments beginning June 1, 2008 and ending March 1, 2009: **\$50 enrollment fee**

\* **Accounts delinquent by more than 60 days will be required to be paid in full directly to the school or assigned to the direct debit option to remain on a payment plan.**

### Acceptance and Payment liability

- **All fees and tuition payments are non-refundable.**
- Registrants for kindergarten are assessed in May for their readiness. Registrants for other grades are also subject to evaluation for subsequent grade readiness. **Final acceptance of this tuition contract will be determined by the results of the assessment/evaluation.** The registration fee will be returned to you if it is determined by the school that your child is not ready for the grade level in which you are enrolling him/her.
- **If for any reason, an accepted student is withdrawn from the School, the parents or guardian remain liable for payment of the student's full tuition.**

**If formal collection procedures are necessary, you will be liable to St. Paul's Academy for all fees and other expenses, including, but not limited to attorney's fees, court costs, litigation expenses and reasonable compensation for efforts conducted by St. Paul's Academy employees or agents to effect collection.**
