**Annual Registration Fees: Toddlers - \$100    Three and four year olds - \$150**

I wish to enroll \_\_\_\_\_ as a student under the following terms and conditions:

- The School reserves a place only when the 2011-2012 registration form, appropriate registration fee, \$50 application processing fee (new students only), this tuition contract, registration summary and if applicable, the Tuition Management System's enrollment form are accepted by the School. **Only one TMS form and registration summary is required per LEPS/SPA family combined.**
- The student's right to attend class is dependent on making **all** payments as scheduled.
- **Students must** be 2 ½ years (toddlers) 3 years old or 4 years old per their appropriate program by August 31<sup>st</sup>.
- The School reserves the right to require the withdrawal of any student who, in the judgment of the School, is not making satisfactory progress or is detrimental to the School and its philosophy.

### **\*Payment Options through Tuition Management Systems\*\***

1. Three payments due the first of June, September, and December: **\$25 enrollment fee**
2. 10 monthly payments beginning June 1, 2011 and ending March 1, 2012: **\$50 enrollment fee**
3. 10 monthly payments beginning June 15th, 2011 and ending March 15th 2012: **\$50 enrollment fee**  
*(This 3rd option requires automatic checking withdrawal)*

\*Accounts delinquent by more than 60 days will be required to either **pay in full** directly to the school **or** sign up for the direct debit option to remain on the payment plan.

\*\* You may elect to pay your tuition in a single payment to SPA on or before **June 1, 2011** and receive the annual payment discount. **Exception: The annual payment discount does not apply to Toddlers.**

### **Acceptance and Payment liability**

- Fees and tuition payments are non-refundable.
- If for any reason an accepted student is withdrawn from the School, the parents or guardian remain liable for payment of the student's full tuition.

If formal collection procedures are necessary, you will be liable to St. Paul's Academy for all fees and other expenses including, but not limited to, attorney's fees, court costs, litigation expenses and reasonable compensation for efforts conducted by St. Paul's Academy employees or agents to effect collection.
